The Aurora Lighting 10 year 100,000 hour Extended Warranty applies to the relevant products purchased on or after 1 June 2013. The period of warranty commences on the date of purchase and is limited to 10 years or 100,000 hours (whichever comes first).

During the period of the Aurora Lighting 10 Year 100,000 hour Extended Warranty, Aurora undertakes to repair or replace free of charge either the whole or any part of the product that Aurora deems to be defective as a result of a material or manufacturing fault.

### **In order to obtain this 10 Year 100,000 hour Extended Warranty you must:**

- Complete all parts of the attached Registration form and return to Extended Warranty Administration, Aurora Ltd, 16 Alban Park, Hatfield Road, St Albans, Hertfordshire, AL4 0JJ, United Kingdom
- Comply with the Terms and Conditions of the Aurora Lighting 10 Year 100,000 hour Extended Warranty Scheme.

### **The 10 Year 100,000 hour Extended Warranty is only valid if:**

- The Date of Purchase is confirmed by an official receipt issued at the time of purchase. Aurora Ltd is promptly informed of the defect
- The product has not been altered or modified in any way
- The product has been installed by a qualified electrician in accordance with the instructions provided
- The product has been used in accordance with the instructions provided (i.e. not subjected to incorrect operation, misuse or connection to an unsuitable power supply)

### **Making a Claim:**

- Return the complete product to the wholesaler from whom the product was originally purchased in the original packaging if possible together with your original purchase receipt.
